


What is NCRA?

Newtown Community & Recreation Association (NCRA) is **a registered charity** and was formed in 1999. The charity purchased the land (outlined below) for the benefit of the Newtown area community and created a playing field, a community garden to celebrate the millennium, a playpark, and a car park.



The NCRA relies entirely on the support of volunteers, donations and grants in order to keep these facilities maintained and open.

Over the past couple of years, the NCRA has embarked on a number of developments to the playground, the car park and a new community garden. This has not been possible without generous donations from local residents, parents/carers, and support from local businesses. We need to undertake continuous fundraising to be able to maintain and update these facilities for the benefit of everyone.

How your donations helps

The playpark alone costs around £2,000 a year just to keep open!

We also need to raise funds to maintain the car park, garden and for any repairs/upkeep of the area. The recent car park extension cost in excess of £31,500 and will cost the charity in excess of a further £20,000 to complete.

If you enjoy using the play park and garden or use the car park, please consider making a donation to enable us to keep these facilities open for all to use.

The NCRA Lottery is open to anyone (18 and over) and plays a vital role in raising funds to maintain the playpark, playing field, community garden and car park owned by the charity.

Entry Fee and Application

There is a monthly draw that takes place on the last day of the month.

NCRA Lottery Terms and Conditions

Terms and Conditions:

- 1.1 The promoter of the NCRA Lottery (the "Lottery") is Newtown Community and Recreation Association, registered charity number 1083905, whose registered address is Brook House, Newtown, Wem, SY4 5NU (the "Charity").
- 1.2 The Charity reserves the right to hold void, cancel, suspend, or amend the Lottery where it becomes necessary to do so.
- 1.4 By purchasing a ticket, participants are deemed to have accepted and agreed to be bound by these Terms and Conditions upon entry. The Charity reserves the right to refuse entry or refuse to award the prize to anyone in breach of these Terms and Conditions.
- 1.5 The Charity reserves the right to make changes to these Terms and Conditions from time to time. Any changes will be communicated to current participants.

2. Participation and Registration in the Draw:

- 2.1 The lottery is open to residents of the UK aged 18 and over.
- 2.2 Participation in the Lottery costs £15 per ticket and will cover 12 monthly draws. You may purchase more than one ticket.
- 2.3 Entries can be made via email with the appropriate form and payment via bank transfer. Individuals may also sign up to participate in the Lottery through one of our face to face fundraisers/contacts.
- 2.5 Following registration and receipt of payment, the Charity will send you confirmation of your entry which will specify your Game Number(s) and expiry date.
- 2.6 Your Game Numbers will be entered into the next available Draw following receipt of payment and will expire after 12 monthly draws.
- 2.7 You are solely responsible for providing and (where necessary) updating the Charity with your accurate and up to date contact details and the Charity will be in no way liable for any failure or inability to contact you due to any errors, omissions or inaccuracies in the contact details that you provide.

3. Proceeds

- 3.1 All proceeds from the lottery will go towards supporting the charity's objects within its Constitution dated 05 January 2000. Monies raised by the Charity in the Lottery will support the ongoing maintenance and any necessary works in relation to the NCRA playpark, playing field, community garden and car park.
- 3.2 Where 50 tickets are sold, the charity will retain 70% of the total ticket sales as profit, and the remaining monies will be allocated to the prize fund.

4. Prizes:

4.1 The prizes for each draw are:

1st Prize - £10

2nd Prize - £5

- 4.2 The prizes are non-exchangeable and non-transferable.
- 4.3 The prizes are subject to change and availability.

5. Odds of Winning:

5.1 The odds of winning depend on the number of tickets sold. The average odds of winning a prize in one monthly draw, with effect from 01 September 2023, are projected to be approximately 1 in 50. These statistics were last reviewed in September 2023 and will be reviewed on an annual basis.

6. Payment:

.1 Payment for participation in the Lottery can be made by cash or bank transfer as detailed on the Application Form.

- 6.2 The Charity accepts no responsibility if payment is not received.
- 6.3 No responsibility is taken for applications and payments which are lost, damaged, illegible or from which the prize-winner cannot be identified, or for any technical failure or event, beyond the Charity's reasonable control, which may cause the Lottery to be disrupted or corrupted. Proof of posting will not be accepted as proof of receipt.
- 6.4 We do not refund ticket purchases.

7. Draw:

- 7.1 The winners will be chosen by random draw (the "**Draw**") from all the entrants in the Lottery, for which payment has been received.
- 7.2 The Draw will be done in the presence of at least two Charity Trustees.
- 7.3 The Draw will be determined by means of a random number generator.
- 7.4 The Draw will take place monthly on or around the last day of the month.
- 7.5 The result of the Lottery is final. If you wish to make a complaint, you must contact the Charity via email (ncracommittee@gmail.com) within 14-days of the draw being held.

8. Winners:

- 8.1 Winners will be notified via email within 14 days of the Draw.
- 8.2 Winners will be asked to confirm their bank details in order that the Charity can transfer their prize via bank transfer.
- 8.3 The Charity accepts no responsibility for the prize not being received by the winner due to incorrect bank details being supplied for the bank transfer.
- 8.4 The winning numbers will be posted on the NCRA Facebook page each month.
- 8.5 Winners may be required to provide proof of age to ensure a winner is not under the age of 18. If satisfactory evidence is not provided within 14-days of the request for proof of age, then the prize will be forfeited, and the Charity will be entitled to select another winner.
- 8.6 If the winner cannot be contacted or does not claim the prize within 14 days of notification, a new winner will be drawn.

9. Legal Disclosures

- 9.1 The lottery is registered with Shropshire Council.
- 9.2 The charity's name is Newtown Community and Recreation Association, registered charity number 1083905, whose registered address is Brook House, Newtown, Wem, SY4 5NU.
- 9.3 The lottery is subject to all applicable laws and regulations.

10. Data Protection

- 10.1 The Charity will always treat your personal details with the utmost care. We will keep your data safe and private, holding the information you provide for communication, marketing, analysis and administrative purposes. For full details of what information we hold and how we process your data, please request a copy of our Data Protection policy.
- 10.2 By purchasing a ticket, you consent to the NCRA contacting you regarding the lottery, including but not limited to informing you if you win, ticket renewal reminders and updates about the charity's activities.
